CALL FOR ABSTRACTS

This conference will be organised by the European Society for Philosophy of Medicine and Healthcare (ESPMH, see http://espmh.org) and the Department of Medical History and Ethics, Acibadem University School of Medicine, Istanbul. The focus of the conference is on the ethical implications of the social determinants of health. There is vast evidence that social factors, including income level, education, employment status, gender and ethnicity have a crucial influence on health. As the World Health Organization's Commission on Social Determinants of Health states, many health inequalities "arise because of the circumstances in which people grow, live, work, and age, and the systems put in place to deal with illness". Drawing on Rawls' theory of justice, Norman Daniels has argued that governments should pursue social strategies (to reduce health inequalities) by implementing policies "aimed at equalizing individual life opportunities, such as investment in basic education, affordable housing, income security and other forms of antipoverty policy". A number of theorists, including Amartya Sen, Thomas Pogge, and others, have proposed different approaches to tackle this challenge. Papers addressing any of the issues mentioned in the headings below will be favoured, although work on other topics can also be submitted.
