Dear Colleagues,

Last August at our 30th Annual ESPMH conference in Zagreb we enjoyed many interesting presentations as well as the hospitality of our Croatian colleagues. Once again I would like to thank Professor Ana Borovecki and her team for having been such a good host.

We are now looking forward to our next meeting in Belgrade, Serbia, 16 - 19 August 2017. You find a call for abstracts for this forthcoming conference on the society's homepage (<u>www.espmh.org</u>). The deadline for submission of abstracts is the 1st of March 2017. Please send your abstract by email to the secretary of the ESPMH. After the selection of abstracts we will make a draft programme and post it on the society's homepage by the end of March 2017.

In order to register for the conference in Belgrade a registration form can be downloaded from the society's homepage at www.espmh.org. It should be emailed to our secretariat.

We have also initiated the preparations for the 2018 ESPMH conference, which will take place in Lisbon, Portugal. The call for abstracts for that meeting will be launched next year.

Finally, there will be elections for positions in the Board of the ESPMH at the Belgrade conference. As a result of the last election in Zagreb, in August 2016, the composition of the Board as of the 1st of January 2017 will be as follows:

According to the By-Laws, Christoph Rehmann-Sutter (currently president-elect) will follow up Roberto Andorno as president of the ESPMH. The three-year term of office of two Board members will finish by the end of 2017 (Gerrit Kimsma and Eugenijus Gefenas). So two board positions will

be up for election during the General Assembly in Belgrade: the position of treasurer as well as one position of regular Board member.

We will follow the procedure as outlined in the By-Laws concerning the election procedure of the Board, which is as follows:

- 1. We invite nominations from the membership.
- 2. The Board will make a proposal on the basis of the nominations received.
- 3. This proposal will be circulated prior to the General Assembly.

If members do not agree with the proposal of the Board, they are invited to prepare an alternative proposal (backed by 10% of the membership). This proposal must be sent to the Secretary or given to the Board prior to the beginning of the meeting at the latest. The proposal of the Board, as well as such proposals of the membership, will be open for voting during the General Assembly. At the same time, members who are not able to attend the General Assembly can request postal ballot sheets from the Secretariat.

With this first step, we would like to invite you to make nominations for the two above-mentioned vacancies in the Board (the position of treasurer as well as one regular member of the Board).

For a valid nomination please follow these rules:

- Specify the name of the person nominated as well as the position (treasurer of the ESPMH or regular member of the Board). Only members of the ESPMH can be nominated;
- We need the written consent of the person nominated (in a letter or via email to the secretariat);
- We need 2 signatures of members who will be making this nomination (names and signatures, through fax, email, or letter);
- The nominations must be received by the secretariat before April 1, 2017.

In making its proposal, the Board will consider the following criteria: geographical diversity, professional diversity, gender diversity and European residency. If you were to consider making nominations, it would be helpful if you could take these criteria into account as well.
